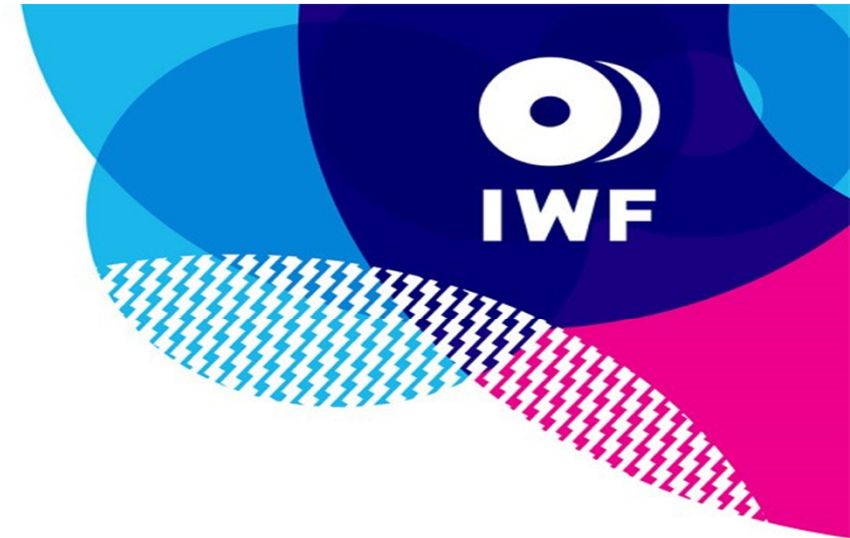

Aspects of the review:

- ✓ Deadline for the payment (15 April 2017, At the latest at the Electoral Congress 27th May 2017)
- ✓ Guyana became Temporary Suspended
- ✓ Temporary Suspension was lifted for: Cambodia, Palestine, Malawi, Guam, Ethiopia, Congo,
- ✓ Rwanda became a new Member of the IWF (192nd Member)

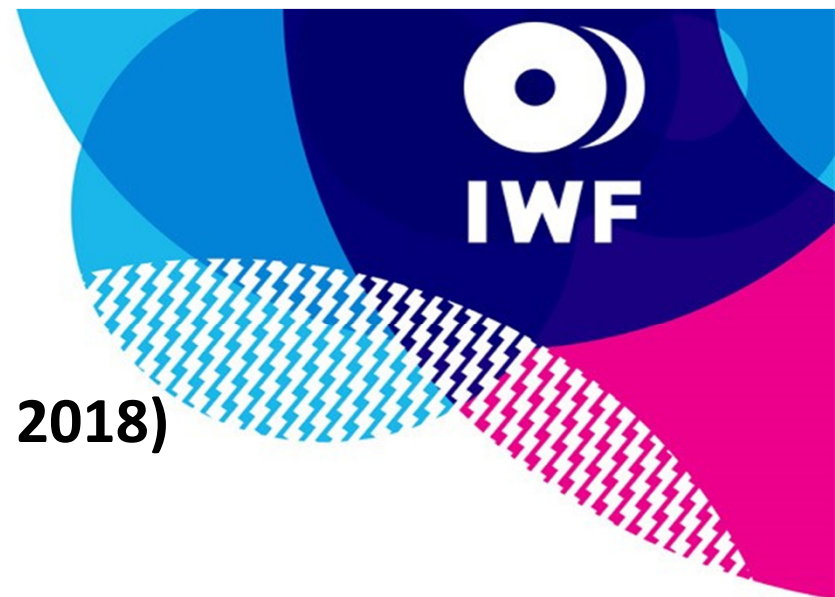

Propopsed deadline for payment (Membership Fee of 2017 and 2018)



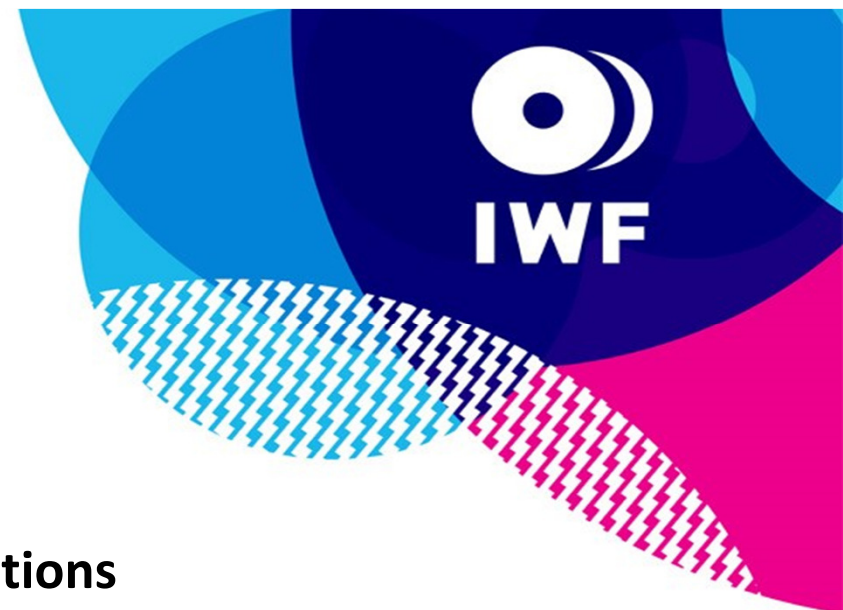

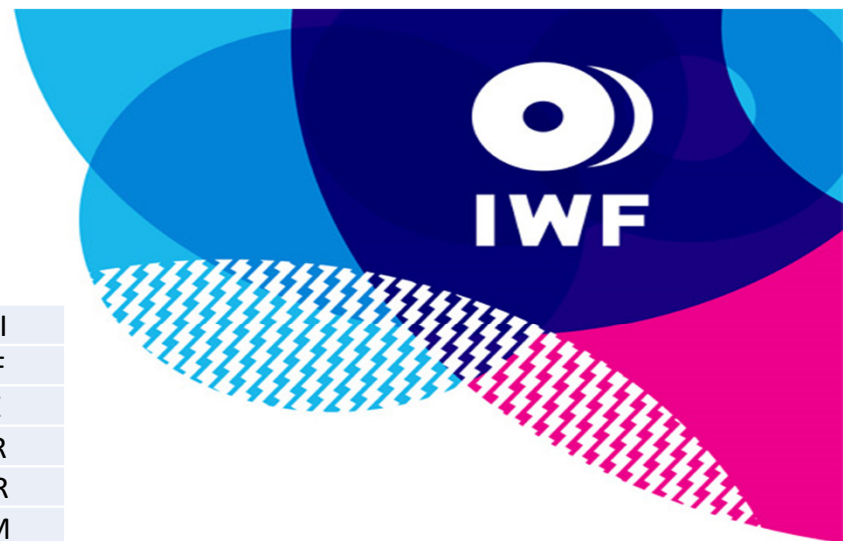

Saint Vincent and the Grenadines (VIN)

- ✓ Paid the Membership Fee for 2017 and 2018
- ✓ Activity in 2018
- ✓ Not combined Federation

Guyana (GUY)

- ✓ Paid the outstanding amount from 2014 which they were suspended
- ✓ Activity in 2017
- ✓ Not combined Federation

Northern Marianas (NMI)

- Member since 1993
- The new Federation was established in 2017.
- The old Federation has outstanding amounts from 2013,2014,2015,2016,
- The newly established Member Federation asked for an exemption for paying the outstanding amounts of the previous Federation
- The EB shall decide if the payment of Membership fee for only 2017 and 2018 is accepted

New application

- Applicant: Cape Verde
 - Evaluation of the submitted documents were done;
 - All documents were submitted according to Article 3.3.1 of the IWF Constitution but the Affiliation Fee was not paid;
 - NOC of Cape Verde would give financial support;
 - For this they need Certificate which shows that the application of Cape Verde is under the recognition of the IWF subject to the payment of the Affiliation Fee;
 - In case the Federation will pay the Affiliation Fee until 1st February 2019
- The Membership Commission will recommend the approval of the application -> at the next Executive Board Meeting held in Las Vegas 2019.**



IWF Membership review

- **Next step:** Approval of the EB subject to the settled payment -> Ratification of the Congress in Las Vegas
- Earliest - twenty- four (24) months after the ratification of the Congress Cape Verde can become Full Member of the International Weightlifting Federation.
