#### **Combined Federations**



• Article 3.1.3 of the IWF Constitution and By-Laws:

"Unless specifically authorised by the Executive Board the combination of weightlifting with other sports that have their own international federations is not permitted."

- Member Federations have been asked of their status by the IWF in December 2018.
- According to the IWF Database 17 Member Federations are combined with other sports.

#### **Provisional Members**

- √ 24 June 2016 Burundi
- ✓ 20 June 2014 Eqatorial Guinea
- "A Provisional Member is a National Federation of a country as defined in 3.1.2 that has submitted its application and is waiting for admission to full membership. Provisional Members may qualify for full membership no sooner than twenty-four (24) months to be counted from the application date." / IWF Constitution Article 3.2.2 /
- 24 months expired
- Apply for Full Membership comply with the 3 conditions proposed deadline: 31 July 2019



#### **New application**

- IWF
- Application for IWF Membership evaluated in Ashgabat;
- Applicant: Cape Verde;
- All documents were submitted according to Article 3.3.1 of the IWF Constitution but the Affiliation Fee was not paid – NOC support
- Deadline was settled for the payment: 31 January 2019
- The Membership Commission recommended the approval of the application. The Application was approved by the IWF EB.
- Cape Verde can become Provisional Member of the IWF (24 months will start after the day of the Congress ratification.)
