The President and the General Secretary explained that the meeting was convened to approve the Constitution draft to be circulated to the Members today to comply with the relevant stipulations of the Constitution. The draft prepared by the 3 lawyers and sent to the EB Members for review would need to be sent out to the MFs right after the meeting. The MFs should send their proposals until 12th May to be incorporated, reviewed and discussed.

A motion was made to approve the final draft subject to certain adjustments to be sent out, this afternoon at the latest, to the member federations for notices and for review.

VOTE 1 to approve the motion as stated above with 16 yes votes, 0 abstention and 9 not online – PASSED.

It was stated that the following in-person IWF Executive Board meeting would be held on 10th June 2023 in Havana Cuba during the 2023 IWF Grand Prix.

There being no other matter to transact, the meeting was closed.
