After the Roll Call, the President welcomed the EB Members joining the meeting, the General Secretary also offered greetings.

The President and the General Secretary informed the EB that the present meeting was convened about the findings of Independent Investigatory Company completed on BLR athletes and support personnel signing the agreement to participate in IWF events, The work had been completed and the results were circulated among the EB members before the meeting.

The floor was given to Conflitti member of the WG created for the purpose and introduced the colleagues from the Independent Investigatory Company who gave a summary on the work and the report sent. **Annex 01.**

Curtain made the motion to approve the 19 athletes and athlete support personnel as being deemed eligible to participate in the upcoming IWF Grand Prix in Cuba as per the IWF Policy.

**VOTE 1 to approve the 19 athletes and athlete support personnel as being deemed eligible to participate in the upcoming IWF Grand Prix in Cuba as per the IWF Policy.
16 yes votes, 0 abstention and 9 not online – PASSED.**

The EB was also informed about the Russian Federation President Maxim Agapitov making statements against the IWF in different media, namely calling the IWF and its Policy discriminative.

Adrega informed the EB about the related press release to be published after the meeting attached hereto as **Annex 02**.

The EB agreed to the proposal made by Curtain to use “Beethoven’s Ode to Joy” as the anthem / neutral melody in the case of a medal ceremony for Individual Neutral Athletes.

There being no other matter to transact, the meeting was closed.
