Welcome speeches were held by Mohammed Jalood, Eshaq Ebrahim Eshaq, Dr. Antonio Urso, Ursula Papandrea.

President Jalood also congratulated Presidents and General Secretaries on their election or re-election in their Member Federation, he named those federations one by one.

Grants of awards by the Host Mr. Eshaq Ebrahim Eshaq, the President of Bharain Weightlifting Federation, who presented awards to:

Eshaq Ebrahim Eshaq was also presented with an award by the IWF.

After the awards and greetings, the roll call was completed for the first part of the Congress:

93 voting delegates attended the Congress in-person, while 41 voting delegates joined online adding up to 135 participants which represent 80,47% of the Member Federations with the right to vote; the qualified quorum required to adopt constitutional amendments (2/3 - that is 66% - of Full Members with the right to vote at the Congress according to Article 15.22 of the IWF Constitution) was thus reached. This special quorum was required only in respect of Votes 1 and 2. The other voting item (n°5) was subject to the ordinary quorum which was reached a fortiori.

Mournianakis informed the Congress that the remaining proposal by the ITA MF was withdrawn before the start of the Congress.

Mournianakis explained to the Congress that the vote on the approval of the constitutional amendments could take place either as a block vote on the approval of the revised constitution including all proposed amendments or by a vote in respect of each amended article (practically 25 separate individual votes as this is the number of articles which are amended in the revised constitution).

The recommendation and proposal were that the IWF Executive Board amendment proposals of the IWF

Constitution should be put to vote as a whole (block vote to approve the Constitution as revised with all amendments). However, if any of the MF Representatives would have an objection to this proposal, then a preliminary vote on the procedural question of whether to hold a block vote or a vote article by article would be held (to be decided by Simple Majority). Mournianakis invited the MF Representatives to express whether any of them had an objection to the proposal to hold a block vote. Representative of LUX raised such objection. Accordingly, a motion was made to decide on the matter of procedure (whether to hold the vote to approve the amendment as a block vote or a vote article by article):

<u>VOTE1– Do you approve to vote on the approval of the Executive Board proposals amending the IWF</u> Constitution as a block vote?

VOTE 1 – 136 votes cast in favour and 1 vote cast against of approving the Constitution amendment as a block vote.

This being a procedural matter and subject to approval by Ordinary Resolution, and the required Majority (50%+1 of the votes cast) being reached the motion for the revised Constitution including all its amendments to be approved with a single vote (by a block vote) has been APPROVED by the IWF Congress.

After the first vote the Congress would proceed to vote through a block vote in regard of the approval or not of the IWF Executive Board proposals for amendment of the IWF Constitution. The applicable majority to approve these proposals was the Special Majority (2/3 - 66% of the votes cast).

VOTE 2 – 131 votes cast in favour of approving the Constitution amendment as proposed by the IWF Executive Board.

The required Special Majority (2/3 - 66%) being reached (99.24%), the revised Constitution including all amendments proposed by the Executive Board has been APPROVED by the IWF Congress.

The 100% majority could be attained; the reports were APPROVED by the IWF Congress.

After the lunch 93 voting delegates members attended in-person, while 30 members joined online adding up to 126 participants which represent 83.44% of the MFs; the quorum was attained.
