After the Roll Call, the President and the General Secretary welcomed the EB Members attending the meeting online.

### **1. Report of the President and the General Secretary**

The President and the General Secretary reported quickly about the IWF World Junior Championships, held in Leon, Spain, which finished in the previous week on Friday noting that it was a record-breaking event with over 350 athletes competing. However, there were significant challenges with accommodations and food, which led to many athletes eating outside the hotels. It was emphasized for the IWF to be more diligent in ensuring proper accommodations and logistics for future major events.

### **2. Discussion of the Proposals to the Constitution Draft, sent by the MFs**

Before the meeting, the EB Members received the Proposals of the Member Federations to the Amendments to the Constitution approved by the IWF EB on 28 August 2024 and circulated among MFs, as well as the Notices of ASOIF on those amendments. (**Annex 01**). Given the floor, Papandrea, the Chair of the CWG summarised the proposals. The working group reviewed all the proposals and provided explanations, with the goal of sending the final proposed amendments to the member federations 60 days before the Congress.

### 3. Situation with the Licensed Barbell Companies

The CEO informed the Board about the situation with the barbell companies.

A motion was made to approve, in principle, to investigate ways to settle the outstanding payments.

**VOTE 2 to approve the above motion with 19 yes votes, 0 abstention, 0 no vote – PASSED.**

There being no other matter to transact, the meeting was closed.
