After the Roll Call, the President and the General Secretary welcomed the EB Members attending the meeting.

1. 2025 IWF Elections

The President gave the floor to Mr. Morand and Mr. Nigon to give a short update in relation to the 2025 IWF Electoral Congress procedures to the EB. Letter of Intents on hosting the 2025 IWF Elections received until the set deadline were also presented. A motion was made to approve Riyadh, KSA as the city hosting the 2025 IWF Electoral Congress.

VOTE 1 To approve the city of Riyadh KSA as the city hosting the 2025 IWF Electoral Congress with 18 yes votes, 1 abstention, 0 no vote – PASSED.

2. 2028 IWF World Championships (WWC)

Venezuela had been approved hosting the 2028 IWF WWC with the condition to resolve the WADA issues. The Board was informed That Venezuela was unable to resolve those issues, thus, the IWF EB considered to allocate the referred event to Astana, KAZ who were ready to pay an event fee of 1.2 million USD based on the letters received from the Ministry of Sport and Tourism of the Republic of Kazakhstan as well as the Weightlifting Federation of Kazakhstan.

A motion was made to approve to re-allocate the 2028 IWF WWC to Astana, KAZ.

VOTE 2 to approve the aforesaid motion with 19 yes votes, 0 abstentions, 0 no vote - PASSED.

3. Approval of Digital Transformation of the IWF

Tsogas summarised the potential agreement to be signed with a Company on the digital strategy of the IWF. The EB discussed and it was agreed to create a Working Group consisting of: Dr. Antonio Urso, Jose Quinones, Matthew Curtain, Achilleas Tsogas from the Secretariat, with the purpose to check the proposal and make recommendations for the IWF Board.

4. Bodyweight Categories

The IWF EB was approached by two continents Oceania and Pan-America with the request to grant them exceptions for early implementation of the new bodyweight categories, having been approved by the Board in December 2024 in BRN at:

- o Pan-American Junior Championships (March 2025, Cuba)
- Oceania Junior/Youth Championships (April 2025, Australia)

With the condition that the records would not be recognised from those events.

A motion was made to approve the early use of the new bodyweight categories for the Pan-American Junior Championships, Havanna, CUB (09-16 March 2025) and the Oceania Junior & Youth Championships, Melbourne, AUS (11-13 April 2025).

VOTE 3 to approve the aforesaid motion with 20 yes votes, 0 abstentions, 0 no vote - PASSED.

5. Continental Federations

A Motion was made to approve exceptionally, that Section 1.B Article 3 ("Funding") of the IWF By-laws enters into force on 1 January 2026. (I.e. to pay the CF contributions in a lumpsum in the upcoming days as most of the CFs would have major events in the upcoming months.

VOTE 4 to approve the aforesaid motion with 19 yes votes, 0 abstentions, 0 no vote – PASSED.

6. Any Other Business

Sperl, joining the meeting from Geneva, informed the IWF EB about the IWF Refugee Team project presented to the UNHCR who agreed to support this projected.

It was decided to create a Commission for the Masters' to be chaired by Ursula Papandrea, Sam Coffa, Antonio Conflitti and Hidilyn Diaz.

There being no other matter to transact, the meeting was closed.
