MOTION 2:

Dear Respected Members of the Board,

This is to kindly to inform you about the results of the motion stated below as sent to You on 26-07-2024 for your kind approval, disapproval or abstention:

MOTION:

To approve the amendment of Article 8.9 IWF TCRR as follows:

8.9 Where all the IWF bodyweight categories are contested at an event, World Records can only be broken in the bodyweight category and the age group where the athlete is entered. Youth athletes (competing in Senior/Junior events) can break Youth Records based on the bodyweight category of the athlete's registered bodyweight and the age group of the athlete at the weigh-in. Junior athletes (competing at Senior events) can break Junior Records based on the age group of the athlete at the weigh-in.

Olympic Record(s) can only be broken in the bodyweight category from the Olympic Games program where the athlete is entered.

At events where only a number of the IWF bodyweight categories are contested, World records in a bodyweight and age group category not being contested can be broken based on the bodyweight category of the athlete's registered bodyweight and the age group of the athlete at the weigh-in.

Results of the Votes:

- Out of 27 (twenty-seven) IWF EB members 25 (twenty-five) EB members cast their vote until the deadline.
- 25 (twenty-five) votes cast in favour of the motion specified above - i.e. voting YES.
