After the Roll Call, the President and the General Secretary welcomed the EB Members attending the meeting. Mr. Ivan Dibos, Honorary IOC Member, Manuel del Castillo, President of PER WF as well as Jose Quinones PAWF president also offered greetings.

## 1. Address by the IOC Sports Director

The President gave the floor to Mr Kit McConnell, IOC Sports Director, who joined the meeting online. Mr McConnell expressed his gratitude for the invitation and for being able to share some thoughts with the IWF leadership.

He then explained to the EB the rationale behind the recent decision of the IOC concerning the definitive sports programme for the 2028 Los Angeles Olympic Games. Mr McConnell underlined that one of the IOC priorities is to keep the overall athlete quota at 10'500 for the traditional sports, in order to keep the sustainability of the event. Moreover, he added that the five new sports in the programme (proposed by LA OCOG) will have an additional quota of 700 athletes, bringing the total number at 11'200 competitors.

Given these requirements, it was extremely difficult to increase the quota for the traditional sports – two exceptions were however done, in sports climbing and 3x3 basketball.

On the topic of increasing the number of bodyweight categories in weightlifting, the IOC Sports Director explained that this would imply a reduction in the number of athletes in each of the categories. According to the IOC standards, a medal event with less than 12 athletes cannot be accepted for a question of "credibility". Therefore, the IWF's proposal to increase the number of events while keeping the same number of athletes, could not be considered.

Mr McConnell encouraged the IWF to keep its firm stance on good governance and fight against doping, and to continue making its best efforts to deliver appealing weightlifting competitions.

Finally, he addressed his best wishes to the IWF Family concerning the upcoming Electoral Congress, to take place in Riyadh (KSA) on May 24-25, 2025.

# 2. IWF Executive Board Membership Update

Antonio Conlfitti, the previous EWF President was recognized for his tremendous efforts and significant contributions to the sport of weightlifting during his tenure on the current board, and he received an IWF award in acknowledgment of his work. Conflitti left the meeting. After that, Astris Hasani was welcomed as the newly elected EWF president.

# 3. Membership Commission Update

After an introduction by the President, Mournianakis and Horvath gave an update on MC matters and presented a spreadsheet containing all African Member Federations and their status which was updated considering their activity (results of the 2025 African Championships), attached hereto as **Annex 01**. They informed the EB that Member Federations which had been suspended but had an activity to show, could submit all the required documents including an activity report and, as long as they met all the requirements, their applications to lift their suspension could be submitted for review to the Membership Committee and, eventually, to the Executive Board and the Congress, if necessary.

Also, there was a proposal by the President on behalf of the Membership Commission to update the status of the two following member federations: Norfolk Islands Weightlifting Federation and Zanzibar Weightlifting Federation, which had been currently both full IWF members. Considering that Norfolk Islands are a territory of Australia and Zanzibar belongs to UR Tanzania; the proposal was to change their status from Full Members to Associate Members.

A motion was made to approve the proposal and to move Norfolk Islands Weightlifting Federation and Zanzibar Weightlifting Federation into the category of Associate Members.

# VOTE 1 To approve the above motion with 25 yes votes, 0 abstention, 0 no vote – PASSED.

After the presentation, the representatives of PAR WF left the room, and the members discussed the proposal. Following an invitation by the President, who stressed the importance of the support of the state and sport authorities of PAR, no EB member objected to holding a vote on the approval of the request of the PAR WF.

A motion was made to approve PAR to host the 2027 IWF WYC in Paraguay.

# VOTE 3 To approve the above motion with 25 yes votes, 0 abstention, 0 no vote – PASSED.

Given the floor Adamfi raised the question when the List of eligible Member Federations including the voting delegates would be published on the IWF web site as it had been in 2022.

Coffa given the floor, proposed the following people to enter to the Hall of Fame of the IWF:

A motion was made to approve the proposal of Sam Coffa.
