## MINUTES of the IWF ORDINARY CONGRESS 2025 May 24 (09:30 am Riyadh, KSA) In-person and by Video Conference via Zoom

Representatives of the IWF Member Federations (MFs) attended both in-person and online as per the attendance sheets attached hereto as Annex 01 and Annex 02.

149 delegates in-person and 3 delegates online attended the Congress at the moment of the roll call, totalling 152 members in attendance representing 88.33% of the MFs with voting rights. The applicable regular quorum (50% + 1 of Full Members entitled to vote) was established and maintained throughout the Congress.

Welcome speeches were held by Mohammed Jaloud, Dr. Antonio Urso, Ms. Ursula Garza Papandrea and HH Prince Fahad Bin Jalawi Alsaud, Vice-President of the Saudi Olympic & Paralympic Committee. Also, Dr. Thomas BACH, the outgoing President of the International Olympic Committee addressed the delegates of the IWF Congress through a video message. After that, a video prepared for the IWF 120th anniversary by the Saudi Weightlifting Federation hosting the IWF Congress, was presented.

Maxat Dastanov presented the 2024 IWF Audited Financial Statements to the IWF Congress.

Zoltan VERES and Colin BUCKLEY made a presentation on the IWF International Coaching Licence.

His Royal Highness Prince Abdulaziz bin Turki Al-Faisal, Minister of Sport and President of the Saudi Olympic and Paralympic Committee was awarded with the IWF Gold Collar, and he was awarded the title of Honorary President for Life of the IWF.

His Highness Prince Fahad Bin Jalawi Alsaud, Vice-President of the Saudi Olympic & Paralympic Committee was also awarded with the IWF Gold Collar.

Mournianakis presented the recommendations of the IWF Executive Board about membership matters including but not limited to lifting suspensions in case of some MFs and adding a new full member to the IWF.
