A motion was made to approve HRH Prince Abdul Aziz as the Honorary President of the IWF subject to his agreement thereto.

VOTE 1 To approve the above motion with 24 yes votes, 0 abstention, 0 no vote – PASSED.

1. Membership Commission Update

After an introduction by the President, Mournianakis gave an update on MC matters including the recommendations of the Membership Commission attached hereto as **Annex 01**.

A motion was made to approve the recommendation of the Membership Commission.

VOTE 2 To approve the above motion with 23 yes votes, 0 abstention, 0 no vote – PASSED.

2. 2024 Audited Financial Statements

Dastanov presented the audited Financial Statements for the fiscal year of 2024, attached hereto as **Annex 02**. A motion was made to approve the 2024 IWF Audited Financial Statements.

3. Order of Elections

Mournianakis given the floor explained the order of Elections for the DAY-2 according to the Bylaws Committees vs. Commissions: Section 2 Part D art. 1.1.3. of the By-laws.

A motion was made to approve to start the elections for the positions to the Committees before the Commissions.

VOTE 4 to approve the aforesaid motion with 21 yes votes, 0 abstentions, 0 no vote – PASSED.

4. 120 years anniversary of IWF

Adrega made a presentation on the story of 120 years anniversary of the IWF attached hereto as Annex 03.

5. Any Other Business

Tsogas given the floor gave an update on *Enhanced Games* to come in Los Angeles 2026. The EB discussed and was not supporting the idea. It was proposed to create a Commission to investigate the matter.

President given the floor informed the EB about his recent visit to TKM expressing their readiness to hold a qualification event for LA 2028 Olympic Games.

A motion was made to approve to TKM to hold a Grand Prix as part of the IWF Olympic Qualification System for LA 2028.

VOTE 4 to approve the aforesaid motion with 21 yes votes, 0 abstentions, 0 no vote - PASSED.

The term of the Ethics and Disciplinary Commission (EDC) was about to expire after the Electoral Congress; a motion was made to extend the term of the EDC until the next Congress to be held in China in 2026.

VOTE 5 to approve the aforesaid motion with 18 yes votes, 0 abstentions, 0 no vote - PASSED.

There being no other matter to transact, the meeting was closed.
