AGENDA OF THE MEETING

Following the conclusion of the IWF Electoral Congress, the meeting was convened by the IWF President and the General Secretary without a specific Agenda to welcome the newly elected IWF Executive Board Members.

After the Roll Call, the President and the General Secretary welcomed the EB Members attending the meeting. On behalf of the Host country, Mohammed Alharbi also offered greetings.

The IWF President proposed in accordance with Article 16.2(h) IWF Constitution to appoint Ms. Doris Marrero (VEN) (with voting rights) and Mr. Mohamed Ahmed Abdelmaksoud (EGY) (with voting rights) to the IWF Executive Board.

The IWF President proposed to approve the list for potential appointments which are to come into effect immediately after the development of the duties and tasks of each of the appointed or co-opted members (including but not limited to EB Co-opted members, chairs of Committees and Commissions etc.). The General Secretary would send the list of proposals to the Secretariat to check whether proposals would be in compliance with the applicable IWF rules and regulations (including the Constitution and Bylaws as well as the applicable eligibility rules, if any).

A motion was made to approve the proposals subject to the compliance check by the IWF Secretariat.

VOTE 1 to approve the aforesaid motion with 20 yes votes, 2 abstentions, 0 no vote – PASSED.

There being no other matter to transact, the meeting was closed.
