I PARTIES

1. The Complainants

- 1 The Complainants are coaches and trainers of athletes in the Weightlifting Federation of Kazakhstan (WFK). In addition, the Ethics and Disciplinary Commission (EDC) of the International Weightlifting Federation has jurisdiction under Rule 20 of the EDC Procedural Rules to open complaints against individuals 'ex officio'.

II FACTUAL BACKGROUND

- 2 The EDC received from the coaches and trainers of WFK, by notification dated 15th June, 2022 a complaint alleging that at World Youth Championships held in Mexico in 2022 the Respondent took part in this event when he was overage and therefor not eligible to compete.
- 3 It should be stated that the World Youth Championships are open to athletes who or will be not older than 17 years of age in the year in which they are held. This is clearly stated in the competition documents issued by the IWF and the host country and on the IWF web page months prior to competition entries being accepted by the host country.
- 4 So that in the year 2022 an athlete was eligible to compete if born on the year 2005 or later. There is also a minimum age which is not relevant for the purposes of the complaint.
- 5 Therefore, if the Respondent turned 18 years of age in the year 2022 he was ineligible to compete.

III SUBMISSIONS BY PARTIES

A. THE COMPLAINANT

- 6 The Complainants case is that the Respondent competed in the Youth World Championships in Mexico whilst overage and therefore not eligible to compete.
- 7 In support of the accusations the Complainant has provided the following documents:

- a. birth certificate of the Respondent showing he was born on 1/10/2004 (annexure “A” hereto) and therefor was to be 18 years of age in 2022
 - b. summary of competitions (stamped by officials) in which the Respondent has competed showing his birth date as 1/10/2004 (annexure “B” hereto)
- 8 It should be noted that the Respondent produced to the IWF officials at the World Youth Championships a passport in his name showing his birth date as 1/10/2005 (annexure “C” hereto).
- 9 The Complainants allege the documents to obtain the passport have been forged.

B. THE RESPONDENT

- 10 The Respondent was provided by the EDC with an opening order date 30/10/2024 seeking his comments and or submissions on the complaint against him.
- 11 To date the Respondent has not replied to the opening order and has made no comment or submission refuting (denying) or clarifying the complaint.

IV. JURISDICTION AND APPLICABLE LAW

- 12 According to Section 3 – Code of Conduct Part A, B Rule 5 of the IWF By Laws.
- 13 Schedule 3, Rule 19 and 21 of the Ethics and Disciplinary Code
- 14 The standard of proof required for a complaint to be sustained is “on the balance of probabilities with a degree of comfort” this being the principal in the decision of “Briginshaw” and other cases. It has also been said the greater the issue the greater the degree of comfort that is required.

V. FINDINGS

- 15 Firstly, as to how and when a false passport may or may not have been procured. This not a matter for the EDC to comment upon but a matter for the authorities in the Respondents home country.
- 16 Having regard to:
- i. the stamped official birth certificate annexure “A” hereto showing he would be 18 years of age in the year 2022;

- ii. the stamped official documents of his competition results annexure “B” showing his birth date coinciding with the birth certificate (annexure A);
- iii. the Respondent was entered to compete in the Junior World Championships this year (see annexure “D” hereto), however, after the EDC wrote to the IWF Organising Committee for the Junior World Championships in Lima Peru to cancel the Respondents accreditation on the grounds that there was a complaint on foot suggesting that the Respondent was in fact born in 2004 and not 2005, the Respondent did not challenge the cancellation of his accreditation;
- iv. together with the lack of any denial, explanation or submissions from the Respondent after 30 October 2024 it is concluded that the Respondent was ineligible to compete at the World Youth Championships in Mexico in 2022 and as such his results should be stricken from the Results Book.
- 17 The Respondent is directed to return all medals won at the World Youth Championships in Mexico in 2022 to the IWF.
- 18 The IWF is to be informed of these proceedings (and also of when the appeal period to the CAS expires) so that a reallocation of medals can be made.
- 19 It is noted that the Respondent was of a young age when these events occurred and may or may not have been the subject of external pressure.
- 20 However, clean and fair sport is the cornerstone of international competitions and as such the penalty for the Respondent is a ban from all IWF events for a period of four years commencing on 30 October 2024 the date when the Respondent was notified of the complaint against him.
- 21 It is noted that the complaint against the Respondent (competing whilst overage) at the Mexico World Youth Championships in 2022 was also made and found against fellow Kazakhstan athlete Alina Koliushko. As such it appears that these events are the result of conduct by unnamed officials within the Kazakhstan Weightlifting Federation.
- 22 Given the finding in paragraph 21 above, the Respondents young age when the offences occurred and his prior seemingly good character the EDC would entertain a reduction of the penalty imposed should the Respondent express his remorse for what has occurred by a notarized letter to the EDC within 30 days of notification of these findings.

ON THESE GROUNDS

The Panel of the Ethics and Disciplinary Commission decides as follows:

1. The complaint is upheld.
2. The decision is pronounced with no order as to costs.
3. The Respondent is banned from all IWF events for a period of four (4) years commencing on 30 October 2024.
4. If within 30 days the Respondent provides a notarized letter to the EDC expressing his remorse for what has occurred the penalty imposed will be reduced to two (2) years but not otherwise.

Remedies: In accordance with Rule 43 of the IWF Constitution (2021 version) (which corresponds to the version of 12 September 2023), the decision of the EDC may only be appealed by a party before the Court of Arbitration for Sport (the CAS). The Code of Sports- related Arbitration (CAS Code) shall apply to the appeal proceedings (Rule 71 Ethics and Disciplinary Commission Procedural Rules 01/04/22).
