This is to kindly inform You about the result of the votes on the motion stated below as sent to You on **10 February 2026**.

MOTION 1:

To approve the establishment, composition, and mandate of the 2026 IWF Constitution Working Group (CWG) under the following terms:

IWF wishes to ensure that its Constitution remains effective, sustainable, and aligned with best practices of the Olympic Movement. In the furtherance of strengthening and improving the IWF Governance Framework, and in order to initiate and guide this process, the 2026 IWF Constitution Working Group (CWG) is established to conduct a thorough review of the IWF Constitution, By-Laws, and other governing documents and policies, and to propose revisions aligned with IOC and ASOIF governance standards.

Composition of the CWG:

- General Secretary: Jose Quiñones
- First Vice President (Chair): Ursula Garza Papandrea
- Continental President and Vice President: Khaled Mehalhel
- Executive Board Member: Sirilak Thatman
- Athletes' Representative: Forester Osei
- Governance Commission Chair: Alberto Miglietta
- Chief Executive Officer: Achilleas Tsogas
- The CWG shall solicit advice and counsel from IWF Attorney Ioannis Mournianakis.
- The IWF Secretariat shall provide the administrative assistance and services to the CWG if needed. The assigned Secretary will be Maria Cseresnyes.

Results of the Votes:

- Out of 26 (twenty-six) IWF EB members 20 (twenty) EB members cast their vote until the deadline.
- 20 (twenty) votes cast in favour of the motion specified above - i.e. voting YES.
