Visa Information for Participants of the 2014 IWF World Championships Almaty

Weightlifting Federation of the Republic of Kazakhstan, on behalf of the Organizing Committee, would like to inform you that Ministry of Foreign Affairs of the Republic of Kazakhstan will be providing its assistance to Weightlifting Federation of the Republic of Kazakhstan and all members of participating countries as well as their officials in obtaining category D1 business visa free of charge. Please note that it is one entry visa with validity period of 30 days.

Section 1 –Visa free regime countries

The Republic of Kazakhstan has visa free regime for period of 30 to 90 days with 13 countries, the list of which you can find here (annex 1).

Section 2 – Countries with simplified visa obtainment procedure

Citizens of 48 countries will enjoy a simplified procedure for obtaining visa free of charge without the need for visa support number (annex 2).

Please note that citizens of 10 countries listed in annex 2 can enjoy visa free period of stay within the territory of the Republic of Kazakhstan, if the period of stay **does not exceed** 15 days. If the period of stay exceeds visa free regime of 15 days, the citizens of those 10 countries are required to follow visa application procedure as specified below under **Section 2**.

Residents of Hong Kong can enjoy visa free regime for the period of 14 days, but in order to stay in the Republic of Kazakhstan for a longer period Hong Kong residents are required to follow visa application procedure specified in **Section 5**.

Participants, that require obtainment of visas, should contact the consulate of the Republic of Kazakhstan abroad on a permanent address or consulate of the Republic of Kazakhstan in the neighboring country and submit the following documents:

- Valid passport (or international travel document). The passport should expire not earlier than 3 months upon expiry of the respective visa;
- Completed visa application form. All participants should apply for business visa of category D1 with validity period of 30 days;
- One colored photo 3.5 x 4.5 cm;
- Copy of passport;
- A copy of invitation letter for participation in the 2014 IWF World Championships, for visa fee exemption;
- Employment verification letter (please see annex 3).

Section 3 – Countries with no diplomatic mission/consulate of the Republic of Kazakhstan

For residents of the countries that **do not** have the Kazakhstan diplomatic mission/consulate, we advise to apply for visa in the nearest diplomatic mission/consulate (see http://mfa.gov.kz/index.php/en/map) as obtaining the visa upon

arrival at the airport of Astana or Almaty may take a long time due to technical constraints of the consular sections.

VERY IMPORTANT:In those countries that have Kazakhstan diplomatic mission/consulate, foreign citizens CANNOT receive the visa upon arrival. You are strictly required to obtain visa before arriving to the Republic of Kazakhstan.

The residents of the countries where there are no Kazakhstan diplomatic mission/consulate have the option of contacting the nearest diplomatic mission/consulate of Republic of Kazakhstan and are required to submit following documents:

- Valid passport (or international travel document). The passport should expire not earlier than 3 months upon expiry of the respective visa;
- Completed visa application form. All participants should apply for visa of category D1 with validity period of 30 days;
- One colored photo 3.5 x 4.5 cm;
- Copyofpassport;
- Copy of visa support letter from the Weightlifting Federation of the Republic of Kazakhstan indicating the **number of a visa support** letter issued by the Department of Consular Service of the Kazakhstan Ministry of Foreign Affairs.
- Employment verification letter (*please see annex 3*).

Section 4 – Visa obtainment procedure upon arrival to the Republic of Kazakhstan

In exceptional cases (only for the residents of the countries with **no** Kazakhstan diplomatic mission/consulate or for individuals that for particular reasons could not contact the nearest Kazakhstan diplomatic mission/consulate), visa can be issued upon arrival at the airport of Almaty or Astana.

VERY IMPORTANT: Please note that in this case the information on the **city of first entry of border** to the Republic of Kazakhstan must be provided upon submission of the request for visa support. You must clearly indicate your **city of first entry of border** to the Republic of Kazakhstan.

Remember: There are only two cities (Almaty or Astana) where the visa can be obtained upon arrival to the Republic of Kazakhstan.

Upon arrival to Kazakhstan make sure you have the following documents with you:

- Valid passport (or international travel document). The passport should expire not earlier than 3 months upon expiry of the respective visa;
- Completed visa application form. All participants should apply for visa of category D1 with validity period of 30 days;
- One colored photo 3.5 x 4.5 cm;
- Copyofpassport;
- Copy of visa support letter from the Weightlifting Federation of the Republic of Kazakhstan indicating the number of a visa support letter issued by the Department of Consular Service of the Kazakhstan Ministry of Foreign Affairs.
- Employment verification letter (please see annex 3).

Section 5 – Standard visa obtainment procedure for all other countries

Residents of all other countries, not listed in annex 1 or 2, but countries of citizenship of which have diplomatic mission/consulate of the Republic of Kazakhstan, should contact Kazakhstan diplomatic mission/consulate and submitthe following documents:

- Valid passport (or international travel document). Passport should expire not earlier than 3 months upon expiry of the respective visa;
- Completed visa application form. All participants should apply for visa of category D1 with validity period of 30 days;
- One colored photo 3.5 x 4.5 cm;
- Copy of passport;
- Copy of visa support letterfrom the Weightlifting Federation of the Republic of Kazakhstan – indicating the number of a visa support letter issued by the Department of Consular Service of the Kazakhstan Ministry of Foreign Affairs.
- Employment verification letter (please see annex 3).

REGISTRATION UPPON ARRIVAL TO THE REPUBLIC OF KAZAKHSTAN:

- Foreigner receives migration cards, which is returned while exiting Kazakhstan.

Fill in the small white migration card on entering Kazakhstan. You should check the

number of stamps on your migration card.

- Residents of the 48 countries, which are exempt from producing visa support

obtaining two stamps (registration and entry). Those who have two stamps in the

migration card don't need to obtain the registration in the migration police. Please keep

migration card with you and submit it at departure.

- Residents from other countries will obtain only one stamp (entry). The

participants with one stamp in the migration card and staying in Kazakhstan for more

than 5 days should contact the organizers who will advise on the arrangements for

obtaining the registration (second stamp in the migration card). The arrangements for

this registration will be communicated to participants later.

- You must keep your migration card to receive your exit stamp on departure.
