- If you are unable to submit a particular document, please indicate the reasons for this and the Eligibility Determination Panel (EDP) shall duly consider these reasons during its eligibility determination procedure. However, it must be noted that it is the responsibility of the Candidate to prove their bona fides and eligibility.
- The EDP may at its discretion request from the Candidates the submission of the original documents or the submission of additional documents, in order to make an eligibility determination.

By signing this document, I confirm that:

- I am a fit and proper person to be a Candidate under the IWF Constitution and By-laws.
- I am eligible under the terms of the IWF Constitution and By-laws to be elected to the IWF Athletes Commission, and I have truthfully disclosed to IWF all facts, matters and circumstances which I believe are relevant to assessing any question as to my eligibility, including, without limitation, any existing or threatened investigation or proceedings initiated against me or other relevant circumstances. In case of doubt as to the relevance of the circumstances, I shall nonetheless provide the information in order to allow a proper assessment by the EDP.
- There is no fact, matter or circumstance which would reasonably cause the EDP to conclude otherwise.
- I acknowledge and accept that the submission of incomplete or untruthful information and/or documentation shall have as a result the rejection of my candidacy and that the submission of a false or untruthful declaration shall, without limitation, constitute a disciplinary offence under the IWF rules.

CONSENT AND WAIVER FORM

Eligibility Determination Procedure for Candidates at the 2026 Athletes Commission elections

Pursuant to the IWF Constitution and By-laws:

- i) I irrevocably and without reservation consent to the jurisdiction of the Eligibility Determination Panel (EDP) to make any decision, determination and adjudication on my eligibility for being a candidate at the 2026 Athletes Commission elections.
- ii) I acknowledge that I shall participate in the candidature procedure in good faith. In particular, I acknowledge that I will be subjected to background checks by the EDP or an independent investigator appointed by the EDP to verify my eligibility to stand as candidate, including by gathering information and/or documents from any sources. I shall provide timely all required information or documents in relation to my candidacy to the EDP or to any independent investigator appointed by the EDP proactively and in any event when requested to do so. I shall comply fully and in a timely manner with any request for further information or documents called for by the EDP in relation to my nomination.
- iii) Upon request, I must obtain and deliver specific documents to the EDP. Failure to deliver such documents may lead to a negative inference.
- iv) I consent to the use of my personal information and data and the waiver of my privacy and data protection rights, for the purpose of my nomination, the assessment and determination of my candidature by the EDP and for and in connection with the elections held during the 2026 IWF World Championships or on any other date and for all related purposes.
- v) I acknowledge and agree that I am bound by the IWF Constitution, By-laws and all rules, regulations, policies, decisions and determinations made by the EDP for the purposes of this candidature, and for and in connection with the elections held during the 2026 IWF World Championships or on any other date and for all related purposes, and will abide by the decisions and determination made in accordance therewith.
- vi) I acknowledge that any determination made by the EDP in relation to my candidacy may be solely appealed to the Court of Arbitration for Sport (CAS) in Lausanne, Switzerland, which shall have exclusive jurisdiction in this respect, including for a request for provisional measures, to the explicit exclusion of recourse to civil or other courts. I understand and accept that the dispute shall be resolved definitively, in accordance with the Code of sports-related arbitration, and the CAS proceedings shall be conducted on an expedited basis. The time limit for appeal is ten (10) days from the publication of the EDP decision in the IWF website.
- vii) I acknowledge that the IWF Constitution and By-laws require that certain information about my candidature and related to my eligibility be published on the IWF Website, and I consent to that publication being made.
